## Terms of Service

### 1. Acceptance of Terms

By accessing or using gamechat.gg (the “Service”), you agree to be bound by these Terms of Service (“Terms”) and our Privacy Policy. If you do not agree, you must not use the Service.

We may update these Terms from time to time. Continued use of the Service after changes are posted constitutes your acceptance of the revised Terms. We will always indicate the date of the most recent update at the top of this page.

### 2. Eligibility

You must be at least 13 years of age to use the Service. If you are between 13 and 18 years old, you represent that a parent or legal guardian has reviewed and agreed to these Terms on your behalf. By using the Service you represent and warrant that you meet these requirements.

### 3. Account Registration

You may register for an account using your email address or a supported OAuth provider (e.g., Google). You agree to:

- Provide accurate, current, and complete information during registration.
- Keep your account credentials confidential and not share them with others.
- Notify us promptly at [support@gamechat.gg](mailto:support@gamechat.gg) if you suspect unauthorized access to your account.
- Be responsible for all activity that occurs under your account.

We reserve the right to suspend or terminate accounts that violate these Terms or that we reasonably believe have been compromised.

### 4. Acceptable Use

#### 4.1 You May

- Use the Service to discuss sports, games, and related topics in real time.
- Create a display name and participate in public chatrooms.
- Share opinions, reactions, and commentary related to live and upcoming sporting events.

## **4.2 You May Not**

When using the Service, you agree not to:

If unresolved, disputes shall be submitted to the courts of competent jurisdiction located in Ontario, Canada, and you consent to the exclusive jurisdiction of such courts.

- Entire Agreement: These Terms and our Privacy Policy constitute the entire agreement between you and gamechat.gg regarding the Service.
- Severability: If any provision of these Terms is found to be unenforceable, that provision will be modified to the minimum extent necessary to make it enforceable, and the remaining provisions will continue in full force.
